

Argentina Approves FORCED Vaccination of entire population

This week, the government of Argentina published the new Compulsive Vaccination Law. Argentines who have not received all the vaccines of the official calendar for children and adults, will no longer be able to process or renew their ID card, passport, prenuptial certificate or driver's license, or access social plans; and ultimately, they may be compulsively vaccinated.

[Law 27,491](#), which establishes compulsory vaccination for all the inhabitants of our country, has already been published in the Official Gazette. The author of the initiative that was approved without debate and unanimously, was the deputy Pablo Yedlin, who estimates that Nation will have to invest U.S. \$ 400 million for the application of the norm, which will be imputed to the items of the general budget of the administration public corresponding to the Ministry of Social Development, guarantor of the acquisition of the required inputs for mass vaccination. **These actions will be carried out in educational establishments, where it will be understood that mediates "tacit authorization" by parents.**

During 2018, there was a significant shortage of MMR vaccines, triple viral and bacterial, which prevented many children from completing their school calendar, which coincided with a 46.4% sub-execution of the health budget in the second quarter of 2018 (last registered). **But the State does not shrink, and with this new law it forces to vaccinate all the inhabitants of our country, during all the life, and declares its vaccination of national interest.**

The complete vaccination will be requested for entry and exit of the school year, the completion of medical examinations of health, processing or renewal of ID, passport, residence, prenuptial certificate and driver's license, processing of family allowances and non-retributive monetary assignments.

What vaccines does the calendar include?

It is impossible to know. The website of the Ministry of Health provides a list, and for better information offers to download a PDF, which has a different list. While in the section of "*Vaccination for adults*" states that the Influenza vaccine must be applied annually, every 10 years the Double Bacterial, the Triple Viral and the Hepatitis B, when downloading the PDF of the National Vaccination Calendar, this indicates that adults must apply Double Bacterial, Double (or Triple) Viral and Argentina Haemorrhagic Fever.

And what happens if you do not get vaccinated?

The letter of the law is clear:

Art. 14.- Failure to comply with the obligations set forth in articles 7, 8, 10 and 13 of this law will generate actions of the corresponding jurisdictional health authority, aimed at effecting the vaccination, which will go from notification to vaccination compulsive

How do you know if you did not get vaccinated?

In order to ensure that there is no lack of personnel to carry out compulsory national vaccination (*read: force vaccination*), the National Registry of Eventual Vaccination is created, an extraordinary mechanism designed to provide a timely and quality response to mass vaccinations. These applications are recorded in the CUV, Unified Vaccination Card, an instrument that integrates the " *National Registry of the Digital Vaccinated Population* ", which will allow the government to have access to the vaccination status of each of the inhabitants of all jurisdictions and subsystems. of health of the Argentine Republic.

Do mandatory vaccines have mercury?

Vaccines against diphtheria, tetanus and pertussis (DTP), hepatitis B, rabies, influenza and Haemophilus influenzae type b (Hib) and meningococcal infections contain different concentrations of thiomersal as a preservative (between 8 and 50 µg per dose). Thiomersal is a compound that contains ethylmercury and is used to prevent the growth of bacteria and fungi.

WHO considers mercury to be one of the 10 products or groups of chemicals with the greatest impact on public health. Exposure to mercury, even in very small amounts, can cause serious health problems, especially in fetal and infant development. Mercury is cumulative and can have toxic effects on the nervous and immune systems, the digestive system, lungs, kidneys, skin and eyes.

The WHO Global Advisory Committee on Vaccine Safety (GACVS) has examined the scientific data on the use of thiomersal as a preservative of vaccines, concluding that there is no evidence that the amount used poses a risk to health .

Is a compulsive vaccination legal?

The Yedlin Law overwhelms the will of the patient, protected by Law 26529, which guarantees the right to reject therapies or medical or biological procedures, with or without expression of cause. Likewise, the presumed "tacit authorization" of the parents of school-age children violates the principle of informed consent, according to which the therapy requires a declaration of express will and after being informed (the patient or his / her tutor) of the characteristics of the treatment and its necessity. **In both cases, the protected legal right is human dignity, which is violated by the new scheme of compulsory vaccinations.**

What controversies generates compulsive vaccination for the entire population?

There is no record in the world of a compulsory vaccination calendar for the entire population of a country, nor of a National Registry of vaccinated persons as the one that is intended to be carried out, however, in Argentina its implementation was expressly processed in Congress , and no repercussion in the media.

How is vaccination in the first world?

In the United States, Donald Trump always made public his position against mass vaccinations. From Twitter you can read several of your messages about it. In 2012, he warned: " *A lot of autism and reactions to vaccines. Stop the mass vaccination immediately. Go*

back to the individual vaccination! What have we got to lose?" And then in 2014 he advanced " If I were President, I would press for adequate vaccinations, but I would not allow massive injections at one time, that a small child can not stand: AUTISM . "

Lots of autism and vaccine response. Stop these massive doses immediately. Go back to single, spread out shots! What do we have to lose.

After taking office, Trump promised the creation of a " *Vaccine Safety Commission* " whose objective will be to investigate the negative effects of vaccines on people. However, after meeting with Bill Gates, the tycoon who has expressed on several occasions that vaccination serves to reduce the population, reversed his project.

One of the most notorious anti-vaccination activists was the American journalist Bre Panton, who continued her campaign after Trump gave up the fight, but died last week of swine flu. Conspiracy or karma, her death meant the removal of a major obstacle for the cartelized industry of the laboratories, as powerful in the United States as in Argentina, where, together with public works contractors, they have been the main contributors to the president's campaign who vacationed borrowed at the Roemmers house.
